THREE WAYS TO EXHIBIT

Option 1: Jimmie Simpson Park

Artists will be awarded space in Jimmie Simpson Park in sequence of submission. While you can request a specific location in the park, there are no guarantees for accommodations. Artists in the park must have their own set-up. Artists are committed to exhibit in the RAW rain or shine. All artists must remain in their allotted location for both days. We provide the area and the artist is responsible for providing their own tent and display materials. Security is present so you can leave your tent up over night at your own risk. Storage is not provided for artwork overnight. Parking is not provided.

Option 2: Retail Space

Artists who wish to exhibit in a retail space will be provided with a list of venues within our boundaries. All other arrangements are the artists' responsibility and a contract will be provided. If you have a preferred venue or have made arrangements with a venue, please indicate this on your submission form.


Option 3: Your Studio

This must be your permanent studio space. We do not provide studio space for the RAW. Please call to make sure you are within our boundaries.

Insurance: Artwork insurance is the responsibility of the artist. Failure to abide by the rules and guidelines of the RAW will result in expulsion on the RAW weekend and/or exclusion the following year.
